THIS YEAR, NABS STAFF WERE INVITED TO GIVE 60 PRESENTATIONS IN-PERSON AND VIRTUALLY THROUGHOUT THE UNITED STATES, INCLUDING ALASKA, TO EDUCATE PEOPLE ABOUT INDIAN BOARDING SCHOOL HISTORY AND IMPACTS. APPROXIMATELY 5,500 PEOPLE RECEIVED EDUCATION IN-PERSON, WHILE AN ADDITIONAL 4,000 PEOPLE WERE REACHED THROUGH VIRTUAL EDUCATIONAL PRESENTATIONS.
