EDUCATION - IN APRIL 2019, NABS LAUNCHED THE FIRST OF ITS KIND RESEARCH STUDY ON NATIVE AMERICAN CHILD REMOVAL IN THE U.S. IN PARTNERSHIP WITH THE UNIVERSITY OF MINNESOTA AND THE FIRST NATIONS REPATRIATION INSTITUTE. THE STUDY WILL BE AN IMPORTANT PART OF OUR EFFORTS TO LEARN MORE ABOUT HOW BOARDING SCHOOLS IMPACTED RATES OF ADOPTION AND FOSTER CARE IN OUR COMMUNITIES AND HOW THESE INSTANCES OF CHILD REMOVAL IMPACTED HEALTH AND WELL-BEING. THE DATA WE COLLECT WILL BE AN IMPORTANT PART OF OUR EFFORTS TO SPARK A NATIONAL CONVERSATION ON THESE ISSUES AND CULTIVATE OPPORTUNITIES FOR HEALING. IT WILL HELP US CONTINUE TO INFORM POLICY REFORM, BEST PRACTICES IN SOCIAL WORK AND HEALTHCARE FIELDS, AND COMMUNITY-LED HEALING INITIATIVES.
